



THIS AMENDMENT AGREEMENT (the “**Amendment**”) to your existing SnapPay Service Agreement, as amended from time to time (the “**Service Agreement**”), is entered into as of the _____ day of _____, 20__ (the “**Effective Date**”) between SnapPay Inc. (the “**Company**”) and _____ (the “**Merchant**”).

WHEREAS the Company and the Merchant desire to enter into this Amendment to the Service Agreement with respect to adding or revising the number of Leased Terminals or Purchased Terminals; **NOW THEREFORE** in consideration of mutual covenants, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. DEFINITIONS

- (a) All capitalized terms used herein shall have the meanings attributed to them in the Service Agreement unless otherwise defined in this Amendment.
- (b) The general terms and conditions and applicable appendices contained in the Service Agreement shall govern the relationship of the parties other than as specifically amended hereunder.

2. AMENDMENTS TO SERVICE AGREEMENT

In addition to the terms and conditions of the Service Agreement, the parties hereby agree that the following provisions shall amend the Service Agreement:

- (a) From the Effective Date, the Merchant will lease and/or purchase the number of Terminals at the amount(s) set out below:

For clarity, if the quantity and the total amount are not completed by inserting the relevant numbers of Terminals to be leased and/or purchased, then the Merchant will not be leasing and/or purchasing any Terminals pursuant to such uncompleted section(s).

3. EFFECTIVE DATE

This Amendment is effective on the date written on the first page hereof.

4. MISCELLANEOUS

Except as amended by this Amendment, all other terms and conditions of the Service Agreement shall remain unamended and in full force and effect. The terms and conditions in the Service Agreement that are contrary to the foregoing provisions will be replaced by the foregoing provisions in this Amendment.

5. ENTIRE AGREEMENT

This Amendment, together with the Service Agreement, represent the entire agreement between the parties hereto relating to the subject matter hereof. No agreement purporting to amend or modify this Amendment shall be valid and binding upon the parties hereto unless it is in writing and signed by all of the parties hereto.

6. GOVERNING LAW

This Amendment shall be construed according to the laws of the Province of Ontario, Canada, and the parties agree to attorn to the exclusive jurisdiction of the courts of the Province of Ontario, Canada.
